## **Do we use ‘cookies’?**

- Yes, we use cookies operated by Google Analytics in order to assess what information is valuable to our visitors. This allows us to gather data, such as page views, and to optimize how fast your site loads. This is required to enable third party tracking. Cookies in and of themselves do not identify the PII of any individual.
- You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. Since every browser
